Since this training course is designed in collaboration with the Association of Southeast Asian Nations (ASEAN), fellowship is available only to ASEAN Members. However, other APT Members and Associate Members could join the training course with their own expenses.

The applications will be considered based upon the following criteria and the documents submitted on time to APT Secretariat in accordance with the "Guidelines for APT Training Course" (Annex-3). The APT Secretariat reserves the right to decline any application.

Selection Criteria:

Qualifications of an applicant:

- 1) University graduate or equivalent with working experience of more than 2 years in the field of telecommunication;
- 2) Government Officer
- 3) Experience over 15 years

If your administration is ASEAN member, you can select one (1) full fellowship or two (2) partial (half) fellowships when nominating the applicants(s) for the training course. In the case of two partial fellowships, the first partial fellowship will cover <u>only</u> the airfare and the second partial fellowship will cover <u>only</u> the hotel accommodation and pocket allowance.

Please note that the above selection criteria will equally apply to both the full fellowship and the partial fellowship.

Required Documents:

- 1. Completed Nomination Form (Annex-2) with current photo, and signatures of the Applicants, Direct Supervisor and the APT official contact person. (The APT shall not accept any Nomination forms without the signature of APT official contact person.); and
- 2. Copy of the applicant's passport with the details and photo page
