INTRODUCTION

The Ministry of Information Technology and Telecommunication (MoITT), Government of Pakistan, is the apex body responsible for policy formulation, regulation, and development of the IT and telecom sectors in the country. The Ministry is committed to leveraging technology to promote economic growth, enhance public service delivery, and improve the overall quality of life of citizens.

In pursuit of these objectives, MoITT is undertaking initiatives to strengthen its digital infrastructure and operational capacity. As part of this effort, the Ministry intends to procure state-of-the-art Office Equipment to support its ongoing and future projects.

This Request for Proposal (RFP) therefore invites eligible bidders to submit their bids via EPADS 2.0 as well as in hardcopy, for the supply and installation of the IT Equipment in accordance with the quantities and specifications outlined at Clause-12 of this RFP.

1. SCOPE OF WORK

Scope of work basically involves supply and installation of IT Equipment as per details mentioned at Clause-12.

Equipment quoted must meet following:

- A. Brand and Model quoted by the bidders must be clearly mentioned as per [Annex-B](#). Only one single brand and model against each item, shall be quoted by the bidder, in case of multiple quotations (Models and Brand) or incomplete quotation (i.e. brand mentioned, complete model not mentioned), the proposal shall be rejected straightaway without seeking any clarifications
- B. It should be brand new, non-refurbished and defect free.
- C. It should have standard warranty and proper documentation must be submitted in this regard by the most advantageous bidder.
- D. Equipment must have local market footprints with parts readily available in local market and economical after sales service.
- E. Joint Venture / Consortium is not applicable.

2. MANDATORY/ ELIGIBILITY CRITERIA:

All bidders must meet following criteria and compliance with below cited criteria is mandatory:

Note: Bidders must note that compliance with above cited criteria is mandatory and in case of non-compliance, the bid will be declared as non-responsive and won't be considered for further technical evaluation

3. BID PRICES

The prices must be quoted in Pakistan Rupees (PKR); the quoted prices should include all applicable taxes, delivery, octroi and all other charges.

4. REJECTION OF BIDS

Ministry of IT & Telecom reserve the rights to accept or reject the bids at any time of the bidding procedure under the Public Procurement Regulatory Authority (PPRA) rules.

5. DELIVERY SCHEDULE AND QUANTITY

Most advantageous bidder will be required to ensure delivery of all equipment as per proposal furnished in response to subject procurement in one single go.

6. PROCUREMENT PROCEDURE

Bids are invited as per Single Stage Two Envelope Procedure as outlined in PPRA Rules.

7. GENERAL TERMS AND CONDITIONS

- A. Quoted Cost must be inclusive of all the applicable taxes, duties transportation and octroi. No extra charges will be paid.
- B. Financial Proposal must be as per format placed at [Annex-A](#).
- C. The Financial Proposal/bid shall not have any over writings or cutting.

- D. Unit price will be taken up to 2 decimal points. The total cost will be round-off. No advance payment will be made.
- E. Only one rate shall be allowed for each item/product/assets/hardware/equipment. Multiple rates in the bids for one item shall not be admissible.
- F. All bids must be unconditionally valid for **120** days and any conditional bid will be rejected
- G. Bids should be submitted electronically only through EPADS (PPRA) Version-02 along with hardcopies as well. For registration and training on EPADS or in case of any technical difficulty in using EPADS, prospective bidders may contact PPRA Team, Director MIS Room No.109, 1st Floor, FBC building Sector G-5/2, Islamabad. - H. All bids must be submitted on EPADs Version-02 along with submission of Hard Copy and Original Bid Security on or before **25-08-2026 @ 11:00 AM**. Bids will be opened on same day **@ 11:30 AM**
- I. MOITT may seek clarification as per **PPRA Rule-31**. Both clarity and response will be in writing. Response must be submitted within stipulated timeline and in case of non-submission, proposal will be declared as non-responsive.
- J. Any bid received after the closing time for submission of bids shall not be entertained.
- K. In case the Bidder intends to withdraw its Proposal / Bid before opening of the Bids, the Bidder can do so through written application addressed to Ministry of Information, Technology & Telecommunication (MoITT). MoITT shall allow the withdrawal of Bid without any consequences to the Bidder. However, after the due date and within the Bid Validity period, if the Bidder intends to withdraw from the procurement process the bid security shall stand forfeited in favor of MoITT.
- L. Substandard, refurbished and none compliant item(s) will be rejected by the MoITT at any stage after or during the supply.
- M. Bidder must quote a single equipment i.e. Brand and model for each equipment without a OR condition and in case bidder is found most advantageous delivery of same equipment as quoted will be must without any request for change.
- N. Supply should be made in proper packing.
- O. If the delivered goods/ equipment's are not according to the required quality, standards / specifications, the same shall be liable to be rejected after inspection. The vendor would be required to replace the same as per specifications mentioned at Clause- 12 without any cost claim and within stipulated timeline, otherwise the purchase order will be cancelled and necessary action will be taken. Further no payment will be made for the equipment supplied.
- P. Most advantageous bidder will be required to submit a performance guarantee amounting to **2%** of overall approved quoted lump sum cost within seven days of issuance of Work Award in form of Bank Guarantee / CDR Valid for 14 months from the date of its issuance or the warranty period of the equipment whichever is more, and in case of non-submission of performance guarantee, the bid security submitted thereof will be confiscated.
- Q. Bid security of unsuccessful bidder will be released subject to completion of necessary procurement procedure. A formal request duly addressed to Project Director, NAAI Project, MOITT Islamabad on official letter head duly signed and stamped will be required.
- R. Bid Security of most advantageous bidder will be released subject to submission of Performance Guarantee as per clause-q above.
- S. In case the most advantageous bidder denies supply of equipment than we reserve the right to initiate necessary blacklisting proceedings as per PPRA Rule-19.
- T. Performance Guarantee will be released subject to successful completion of defect liability / warranty period of one (1) year from the date of satisfactory supply of

equipment. During defect liability period all queries and minor repair and maintenance will be borne by vendor free of cost.

U. The MoITT reserves the right to increase or decrease the quantities of listed items.

8. EVALUATION OF PROPOSALS:

All proposals furnished through EPADs version-02 will be evaluated as per following procedure:

8.1. Technical Evaluation:

First of all, technical proposals will be opened and subject to mandatory criteria compliance, technical scrutiny of proposals will be done as per following criteria:

Minimum Qualifying Score

At least **70%** marks are required for the bidder to be eligible for the next step i.e. Financial Evaluation.

After technical scrutiny, technical evaluation report will be uploaded on all relevant forums and subject to completion of necessary timeline and settlement of grievances if any, financial proposals of technically responsive bidders will be opened

8.2. FINANCIAL EVALUATION:

Financial Evaluation of technically responsive bidders will be carried out. Following course of action will be adopted:

- A.** First computational check will be done
- B.** Compliance of proposal with financial format placed at [Annex-A](#) will be checked.

9. DETERMINATION OF MOST ADVANTAGEOUS BIDDER:

Most Advantageous Bidder will be determined on the basis of Least Cost. The Technical Responsive Bidder with the Least cost offered in the specific Lot will be determined as the most advantageous bidder.

10. PENALTY:

The rate of penalty in case of late delivery of goods beyond the periods specified in the Delivery Schedule, penalty @ 0.1% per day of the cost not exceeding 10% of the purchase order/contract value for late delivered supply shall be imposed upon the Supplier.

Quality is extremely important and vendor must ensure delivery of same equipment i.e. brand, model and no compromise on quality will be allowed.
